
Terms and Conditions of Shariah-Compliant Futures (“SCF”) Reward Campaign 2.0 (“Terms & Conditions”)

About

The SCF Reward Campaign 2.0 (“**Campaign**”) is organized by CGS International Futures Malaysia Sdn. Bhd. (formerly known as CGS-CIMB Futures Sdn. Bhd.) (“**CGS MYF**”) and is valid from 1st June 2024 to 31st December 2024, both dates inclusive (“**Campaign Period**”).

The Terms & Conditions of the Campaign are as set out below.

Eligibility

1. Subject always to the Terms & Conditions contained herein, the Campaign is open to: -
 - a) all CGS MYF’s retail clients with an existing SCF trading account (“**Account**”) and conduct trades in SCF Products (as defined in Clause 5 below) during the Campaign Period; and
 - b) all new CGS MYF’s retail clients who successfully opens an Account and conduct trades in SCF Products (as set out in Clause 5 below) during the Campaign Period.
2. The following persons are NOT eligible to participate in the Campaign:
 - a) institutional and corporate clients; and
 - b) others as may be determined by CGS MYF at its absolute discretion.
3. The clients as listed in Clause 1(a) and (1)(b) will be automatically registered for participation in the Campaign when they trade a minimum of ten (10) lots SCF Products using their Account during the Campaign Period (“**Eligible Participants**”), via QST@ CGS International Futures Malaysia, by calling-in to CGS MYF’s central dealing desk or through a CGS MYF’s Commissioned Futures Broking Representative (“**CFBR**”).
4. The top ten (10) Eligible Participants with the highest Total Brokerage (as defined below) using their Account during the Campaign Period (“**Qualified Participants**”) will be rewarded with rewards as set out in the table below (“**Reward**”) accordingly to their respective ranking. For the avoidance of doubt, there will be a total of ten (10) Reward where the Eligible Participant with the highest Total Brokerage being ranked first and the Eligible Participant with the second highest Total Brokerage being ranked second and shall continue accordingly from the highest to lowest until ten (10) Eligible Participants have been selected.

CGS MYF is entitled to amend, remove or include any new SCF products into the list of SCF Products above during the Campaign Period at any time at its sole discretion.

6. In the event where there is more than one (1) Eligible Participant with the same Total Brokerage, the Eligible Participant who achieves the highest aggregate Total Brokerage for SCF Products on the earlier date and time during the Campaign Period will be ranked higher.
7. The “Total Brokerage” is defined as the cumulative net commission paid to CGS MYF pursuant to the trading in SCF Products by the Eligible Participant using the Account during the Campaign Period. 14. The Reward is non-transferable, non-refundable, and non-exchangeable for cash or credit or benefits in kind whether in part or in full.
15. Further, no responsibilities are accepted for any additional expenses, omissions, delays, re-routing, or acts of any government or authority.
19. Although CGS MYF will endeavor to deliver the Reward promptly, CGS MYF shall not be responsible for any delay, nor will there be any compensation payable for any such delays.
20. In no event will CGS MYF be liable for any loss or damages (including without limitations, loss of income, profits or goodwill, direct or indirect, incidental consequential, exemplary, punitive or special damages or any party including third parties) howsoever arising whether in contract, tort, negligence or otherwise, in connection with the Campaign, even if CGS MYF has been advised of the possibility of such damages in advance, and all such damages are expressly excluded.
21. CGS MYF reserves the right, at its absolute discretion, to:
 - i. extend, modify, shorten, discontinue, cancel, terminate, or suspend the Campaign with or without any prior notice. For the avoidance of doubt, any extension, modification, discontinuation, cancellation, termination, or suspension of the Campaign shall not entitle any of the Eligible Participants to any claim for compensation against CGS MYF or any losses or damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of extension, modification, discontinuation, cancellation, termination, or suspension.

23. All other terms and conditions applicable to the Eligible Participants' trading via their Account(s) shall continue to apply. Nothing herein shall affect such terms and conditions relating to Eligible Participants' trading via Account(s) to which the Eligible Participants have agreed to.

24. CGS MYF will notify the Eligible Participants if they have qualified for a Reward by sending an email to the Eligible Participants' email addresses maintained in CGS MYF's records. Pursuant to the requirements of the Personal Data Protection Act 2010, CGS MYF is required to obtain client consent for the processing of client's personal data. Therefore, the Eligible Participants hereby consents to CGS MYF's processing of the Eligible Participants' personal data which the Eligible Participants may provide to CGS MYF now and from time to time in connection with their applications or participation in the Campaign. The Eligible Participants hereby confirm that they have read, understood and agree to be bound by the CGS MYF's Group Privacy Notice (which is available at www.cgsi.com.my or itrade.cgsi.com.my ("**Privacy Notice**") and the clauses herein, as may relate to the processing of his or her personal information. For the avoidance of doubt, the Eligible

Participants agree that the said Privacy Notice shall be deemed to be incorporated by reference into these Terms & Conditions.

25. The Qualified Participants agree and authorize CGS MYF to disclose their details (including but not limited to name, NRIC number, telephone number, address) to the Third-Party Provider who would then contact the Qualified Participants regarding the delivery of their Reward. The Qualified Participants shall be responsible to make the necessary arrangements with CGS MYF and/or its Third-Party Provider for the delivery and/or collection of the Reward, and for any costs whatsoever incurred in connection with the Reward, including but not limited to transportation from the Third-Party Provider's office location and any other third-party costs. The Qualified Participants shall be responsible to pay any taxes including sales & services tax, incidental cost and/or any other charges relating to any of the Reward unless stated otherwise. 27. The Terms & Conditions as set out above shall be governed by the laws of Malaysia. The Eligible Participants agree to submit to the exclusive jurisdiction of the Courts of Malaysia, but CGS MYF will be at liberty to proceed against the Eligible Participants in any court in any jurisdiction.
