



Terms and Conditions for Contracts For Difference Campaign 2024 (“Terms & Conditions”)

Campaign Name

Contracts For Difference (“**CFD**”) Campaign 2024 (“**Campaign**”)

About

This Campaign is organised by CGS International Futures Malaysia Sdn. Bhd. (formerly known as CGS-CIMB Futures Sdn. Bhd.) (“**CGS MYF**”) and is valid from 1st April 2024 to 31st December 2024, both dates inclusive (“**Campaign Period**”). Each of the Eligible Participants (as defined below) who meet the Accumulated Brokerage (as defined under Clause 3 below) requirements by trading in CFD products within the Campaign Period will be entitled to a reward based on the different tiers more particularly described in Clause 3 below.

Eligibility

Subject always to the Terms & Conditions contained herein, the Campaign is open to all new and existing individual clients of CGS MYF with a CFD trading account and conduct trades in CFD products during the Campaign Period (the “**Eligible Participants**”).

The following persons are NOT eligible to participate in the Campaign:

- (a) Institutional and corporate clients of CGSMYF’s; and
- (b) Others as may be determined by CGS MYF at its absolute discretion.

Mechanics & Reward

1. Eligible Participants will be automatically registered for participation in the Campaign when they trade in CFD products during the Campaign Period, via IRESS trading platform or by calling in to CGS MYF’s central dealing desk or Commissioned Futures Broker’s Representative (CFBR).
2. All CFD products listed on the CGS MYF’s corporate website at <https://www.cgsi.com.my/> and the margin watchlist on the IRESS trading platform at www.viewpoint.iress.com.sg, including new CFD products added to the product list during the Campaign Period traded by the Eligible Participants will be taken into account for purposes of computing the Accumulated Brokerage (as defined in Clause 3 below) paid by Eligible Participants for this Campaign.
3. Each of the Eligible Participants whose Accumulated Brokerage are as set out in the table below within the Campaign Period (“**Qualified Participants**”) will be awarded with a reward (“**Reward**”) based on the different tiers as set out below: -

*For the avoidance of doubt, Apple CFD means a CFD whereby the underlying instrument is the shares of Apple Inc. (Stock Code [AAPL](https://www.cgsi.com.my/)).



The Accumulated Brokerage is calculated based on the gross brokerage paid to CGS MYF for the CFD transactions executed via the CFD trading account of the Eligible Participants within the Campaign Period. The gross brokerage paid is inclusive of commission, exchange levy and clearing fee generated by Eligible Participants during the Campaign Period but excludes any other charges, fees and taxes (including sales and services tax and stamping costs).

- For the avoidance of doubt, a Qualified Participant shall only be allowed to claim the Reward that corresponds with the tier of the Accumulated Brokerage (as set out in Clause 3 above) that applies to the Qualified Participant. Any request to swap or substitute the Qualified Participant's Reward with that of another tier shall not be entertained by CGS MYF.

For example:

Mr A's Accumulated Brokerage is RM80,000.00, thus he is entitled to Apple CFD worth RM4,000.00. Mr A is not allowed to change to Touch 'n Go eWallet credit(s) or any rewards from other tiers.

- Qualified Participants who are entitled to the Reward in the form of Touch 'n Go eWallet credits are required to have the Touch 'n Go mobile application installed prior to receiving the Reward from CGS MYF and CGS MYF reserves the absolute right to forfeit the said Reward should any of the Qualified Participants refuse or do not wish to install the Touch 'n Go mobile application.
- Qualified Participants who are entitled to the Reward in the form of Apple CFD are required to complete the necessary documentation and provide the authorisations deemed required by CGS MYF for the purposes of providing the Apple CFD to the Qualified Participants. For avoidance of doubt, the provision of the Apple CFD by CGS MYF shall be subject to CGS MYF receiving the duly executed authorisation letter in such form as stipulated by CGS MYF and CGS MYF reserves the absolute right to forfeit the said Reward if CGS MYF does not receive a duly executed authorization letter and other necessary documents by the cutoff date to be determined by CGS MYF.
- The quantity of Apple CFD to be purchased, will be rounded down to the nearest whole unit of Apple CFD and is determined by based on the prevailing foreign exchange rate and settlement price of Apple CFD on the day before the Apple CFD are credited into the Qualified Participant's CFD trading account, taking into account any cost incurred for the purchase of the Apple CFD. The Qualified Participants who are entitled for the Apple CFD shall be responsible to pay for any cost incurred relating to the purchase, holding and selling of the Apple CFD including but not limited to commission, exchange levy and clearing fee and financing fees as long as the position for the Apple CFD is held open. In the event there is remaining cash credit after the purchase of the Apple CFD, the Qualified Participant can utilize it for any purpose intended.

Solely for the purposes of illustration, if the Qualified Participant is entitled to receive Apple CFD worth RM4,000, the following calculations will be effected:

Assumptions

Previous day settlement price of an Apple CFD: USD180

Foreign Exchange rate: 1 USD to MYR 4.70

Hence the number of Apple CFD to be received by the Qualified Participant's shall be:

8. The details of the Apple CFD rewarded to the Qualified Participant will be reflected in the Qualified Participant's daily CFD activity statement.
9. Each Qualified Participant is entitled to one (1) Reward only.
10. The Rewards will be delivered from 1st April 2025 onwards.

General Terms and Conditions

11. By participating in the Campaign, all Eligible Participants are deemed to have read, understood and agreed to be bound by these Terms & Conditions and agreed that any decisions of CGS MYF in relation to every aspect of the Campaign, including the Reward to be given away and the determination of the Eligible Participants, Qualified Participants and Accumulated Brokerage, is final, binding and conclusive. No correspondence, queries, appeals or protests will be entertained. CGS MYF reserves the absolute right to reject an Eligible Participant's participation in the Campaign for any reason whatsoever.
12. All prices and value stated here are correct at the time of printing. Reward images shown in any marketing and advertisement collateral are for visual purposes only and may vary from actual Reward received. The Qualified Participants shall be responsible for any costs whatsoever incurred in connection with the Reward, including but not limited to transportation from the Reward's merchant's office location or any other third party costs.
13. The Qualified Participants shall be responsible to pay any taxes including sales & services tax, incidental cost and/or any other charges relating to any of the Reward unless stated otherwise. CGS MYF shall not be held liable for any tax, incidental cost, charges and/or damage caused by any of the Reward and/or non-fulfilment by any of its agents/distributors/service providers.
14. The Reward is non-transferable, non-refundable and non-exchangeable for cash, credit, goods or benefits in kind whether in part or in full.
15. The Reward shall also be subject to the terms and conditions of the respective merchant or company providing the Reward and those terms and conditions shall be in addition to the Terms and Conditions contained herein. The Reward shall be valid for use up to the date as determined by the reward provider ("**Validity Date**"). In the event that the Reward remains unused or unredeemed after the Validity Date has expired, any request by the Qualified Participants to replace or extend the validity of the Reward shall not be entertained.
16. By participating in the Campaign, the Eligible Participants agree to be bound by the Terms & Conditions herein and also the terms and conditions governing their respective CFD trading accounts. All other terms and conditions applicable to the Eligible Participants' trading in CFD products via their CFD trading account shall continue to apply. Nothing herein shall affect such terms and conditions relating to Eligible Participants' trading in CFD products via their CFD trading account to which the Eligible Participants have agreed to.
17. CGS MYF reserves the right, without prior notice and without assigning any reason whatsoever, to substitute any Reward with other item(s) of similar value, including but not limited to, the right to substitute Apple CFD with another share's CFD without prior notice.
18. To the fullest extent permitted by law, CGS MYF expressly exclude and disclaim any representations, warranties, or endorsements, express or implied, written or oral, including but not limited to any warranty of quality, merchantability or fitness for a particular purpose in respect of the



- Reward. Further, no responsibilities are accepted for any additional expenses, omissions, delays, re-routing, or acts of any government or authority.
19. Although CGS MYF will endeavor to deliver the Reward promptly, this is subject to availability and accordingly, CGS MYF shall not be responsible for any delay nor will there be any compensation payable for any such delays.
 20. In no event will CGS MYF be liable for any loss or damages (including without limitations, loss of income, profits or goodwill, direct or indirect, incidental consequential, exemplary, punitive or special damages or any party including third parties) howsoever arising whether in contract, tort, negligence or otherwise, in connection with the Campaign, even if CGS MYF has been advised of the possibility of such damages in advance, and all such damages are expressly excluded.
 21. CGS MYF reserves the right, at its absolute discretion, to:
 - i. extend, modify, shorten, discontinue, cancel, terminate or suspend the Campaign with or without any prior notice. For the avoidance of doubt, any extension, modification, discontinuation, cancellation, termination or suspension of the Campaign shall not entitle any of the Eligible Participants to any claim for compensation against CGS MYF or any losses or damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of extension, modification, discontinuation, cancellation, termination or suspension.
 - ii. vary (whether by addition, deletion, modification, amendment or otherwise howsoever) (the “**Amendment**”) any of the Terms & Conditions herein at any time. The Amendment shall be effected at CGS MYF’s absolute discretion through any one of the following means of communication, namely, by email to the Eligible Participants’ email address maintained in CGS MYF’s records or via CGS International Securities Malaysia Sdn. Bhd’s (formerly known as CGS-CIMB Securities Sdn. Bhd.) (“**CGS MY**”)- official social media platform(s) or via CGS MY’s website at <https://www.cgsi.com.my/> and the Amendment shall be deemed as binding on the Eligible Participants as from the date of notification of the Amendment (through one of the above means of communication) or from such other date as may be specified by CGS MYF in the said notification. These Terms & Conditions, as may be varied or amended from time to time pursuant to this Clause, shall prevail over any provisions or representations contained in any other promotional materials advertising the Campaign.
 22. This Campaign shall not be construed as an offer, recommendation or solicitation to buy or sell CFD products. All Eligible Participants are advised to make their own independent evaluation and to consult their professional advisers before undertaking any transaction.
 23. CGS MYF will notify the Eligible Participants if they have qualified for a Reward by email to the Eligible Participants’ email addresses maintained in CGS MYF’s records. Pursuant to the requirements of the Personal Data Protection Act 2010, CGS MYF is required to obtain client’s consent for the processing of client’s personal data. Therefore, the Eligible Participants hereby consent to CGS MYF’s processing of the Eligible Participants’ personal data which the Eligible Participants may provide to CGS MYF now and from time to time in connection with their applications or participation in the Campaign. The Eligible Participants hereby confirm that the Eligible Participants have read, understood and agree to be bound by the CGS MYF’s Privacy Notice (which is available at <https://www.cgsi.com.my/>) (“**Privacy Notice**”) and the clauses herein, as may relate to the processing of his or her personal information. For the avoidance of doubt, the Eligible Participants agrees that the said Privacy Notice shall be deemed to be incorporated by reference into these Terms & Conditions.



24. The Eligible Participants agree and authorize CGS MYF to disclose their details (including but not limited to name, NRIC number, telephone number, address) to the vendor/distributor/agent/service provider who would then contact the Eligible Participants regarding the delivery of their Reward. The Eligible Participants shall be responsible to make the necessary arrangements with CGS MYF and/or its vendor/distributor/agent/service provider for the delivery and/or collection of the Reward. All taxes, charges and incidental costs in this regard shall be borne by the Eligible Participants.
25. The Eligible Participants hereby agree that in the event that they are not contactable, CGS MYF reserves the right to forfeit the Reward without any prior notice.
26. The Terms & Conditions as set out above shall be governed by the laws of Malaysia. The Eligible Participants agrees to submit to the exclusive jurisdiction of the Courts of Malaysia, but CGS MYF will be at liberty to proceed against the Eligible Participants in any court in any competent jurisdiction.
